Jesus said, "That is why I tell you not to worry about everyday life—whether you have enough food and drink, or enough clothes to wear. Isn't life more than food, and your body more than clothing? #### "Give thanks to the LORD, for God is good, for God's steadfast love endures forever! Psalm 107:1

God is doing amazing, wonderful, spectacular things through you and North Presbyterian Church. North Presbyterian Church has fewer worshippers and financial resources. And we are extravagant in our love, gracious in our serving, faithful in our worship, generous in our giving, an inspiration to our community and inspiring with spiritual wisdom. Please join me in being grateful for all God is doing through us. Jesus told parables about the Kingdom of God involving a small amount of loving (a mustard seed, yeast) having supernatural impact on the world.

# THERAPEUTIC MUSIC MINISTRY

The Therapeutic Music Ministry (TMM) program continues to be a beneficial and important program in the care of our congregation. The program was started in our church in late 2016.

In 2023, there were 11 therapeutic music visits made to several individuals.

Mary Livingston, a Certified Music Practitioner, conducts this ministry with oversight from the Board of Deacons. During a one-on-one session, she uses keyboard, accordion, or harp – depending on the individual's needs/wishes – to create an environment that facilitates healing. People who receive the TMM visits are experiencing health challenges, medical treatments, or mental stress. Recipients respond in positive ways as they are able and the response from caregivers remains very positive.

Therapeutic Music sessions are a gift from the church and therefore are free to the person receiving the visit. The Board of Deacons are grateful to the Session, the Endowment Committee, and to the individual donors who have provided financial support to this program. We are thankful to Mary for sharing her skills, talents, and caring ministry with our members in this way.

Our youth ministry is a joint venture of Church of the Way, New Life, Kenyan Christian Outreach and North. The following opportunities were offered our youth: Workcamp in Puerto Rico, MN State Fair excursion and lock in, Clearwater Snow Retreat, All Saints Lock-in and weekly Wednesday youth fellowship at Church of the Way and biweekly Sunday fellowship at New Life and monthly Sunday Seasons fellowship at North. Spencer York joined Pastor James in leadership. Adult female leaders from the other churches attended all the events.

Active youth are invited to attend workcamp in Chicago, June 28-July 6, 2024, with the support of Praying Pelican Missions. Youth are also invited to attend summer camp at Presbyterian Clearwater Forest.

Plans for next year are fluid. We are exploring continuing our partnership with Church of the Way Shoreview, New Life and Kenyan Christian Outreach. And we are also in dialogue about forming a presbytery wide youth ministry. Presbyterian Youth Triennium will be July 28-31, 2025, in Louisville, Kentucky. We will have weekly opportunities for our youth at one of our partner churches. We will offer the All Saints Lock-in and Clearwater Snow Retreat. Youth who are active in our offerings will be offered a summer mission trip experience.

The youth and leaders thank the congregation for their continued support of the youth ministry at North Church.

- Year-end financials left North Church with a deficit we hope to minimize in 2024.

# **ENDOWMENT COMMITTEE**

**Purpose:** The Endowment Committee was established as a vehicle to receive, invest and maintain funds whereby the principal / original gifts are preserved and allowed to grow, and a portion of growth and investment earnings are used each year for important missions and aspects of church life beyond what would usually be covered by the operating budget.

**Members:** Norm Purrington (Chair), Cindy Carlson (Co-Chair), Paul Colton, (Secretary), Aaron Hill (Co-Investment Advisor), Susanne Meyer (Co-Investment Advisor), Cathy Hickman (ex-officio, Treasurer), Mary Morrissette, George Smith, Doug Pepin (Session), and Bruce Beck.

As of **December 31, 2023**, there was **\$1,326,771** (vs \$1,027,323 as of 12/31/22) in the combined investment fund accounts (\$1,278,859) and cash accounts (\$47,912) for endowment purposes. The investment fund accounts (\$1,278,859) are invested either through Vanguard (\$1,163,395) or The Presbyterian Foundation (\$115,464). Cash is maintained in the NPC bank account.

The investment fund balances, including cash, as of 12/31/23 year-end:

- Unrestricted general endowment fund aggregate balance was \$853,087 and the designated / restricted funds total was \$473,685.
- The total in designated / restricted funds (\$473,685) included The Ralph, Margaret, and Bruce Corwin Memorial Music Fund (\$45,763), The Leisman Mission Fund (\$12,560), The Hoklas Estate Fund (\$121,496), The Purrington Youth Development Fund (\$121,413), The Cliff & Mary Japs Fund (\$139,989), and the Kathryn Hill Fund (\$32,464).

In the past year, allocations from endowment funds supported: music ministry through funding purchase of choir music, stipends for guest choir members, children's Christian education resources, supplies for Season's worship, costs for establishing the hospitality room, technology purchases for worship, and camperships for Clearwater Forest.

### **AUDIT REPORT**

We have reviewed the financial records of North Presbyterian Church for the calendar year ending **12/31/2023.** Our review on <u>March 25, 2024</u> included, but was not limited to:

- 1) Review of cash deposits:
  - a. Randomly selected and reviewed 6/24 of the counter sheets and verified that cash recorded on the sheets matched the deposits per the bank statement. No irregularities were found. It was observed that at least two counters were present for the 6 documents reviewed. Each counter sheet had a signature of the depositor of the funds at Premier Bank.
  - b. With the assistance of Cathy Hickman, Co-Treasurer, and Nancy Gerhardson also reviewed the process whereby donor records in Realm/Vanco (and ultimately giving statements) are matched / verified with QuickBooks (GL) and fund distribution documents and how corrections/ transfers are done (if need be) to correspond with donor wishes.
  - c. NPC continued the use of Realm/Vanco and "cash app" for receipt of cash and credit donations. Reviewed sections of select reports (for confidentiality) to match with bank statements.

Realm/Vanco requires annual compliance reviews of practices and procedures by their users. Their review of NPC was done by Vanco with no negative findings.

- d. NPC receives monthly donations through Hubbard Press. Donors receive a form to request donations through Hubbard Press from the Financial Secretary.
- 2) Review of bank statements and reconciliation reports:
  - a. Verified dual control procedures were followed. In each case, the person opening the bank statement was not an account signer. Renee Kristensen signed as opener on each statement.
  - b. Checks written on account appear normal and appropriate in the normal course of operations.
  - c. Verified account reconciliation reports were prepared and checked against the bank statement each month by the church Treasurer.
- 3) Select review of invoices:
  - a. A random batch of 6 invoices was reviewed. No irregularities were found. A "Request for Payment" was completed by Renee Kristensen or Pastor James. Renee Kristensen verified the account, approved the amount of the checks and attached the form to each invoice.

- b. Cathy Hickman writes the checks based on "Request for Payment". Renee Kristensen mails the checks; Cathy Hickman reviews and initials before the documentation is filed.
- 4) Office checking account and charge card:
  - a. The smaller church office checking account was reviewed with no irregularities noted. This account maintains a modest \$1000 target balance, with minimal checks written. There is a debit card connected to this account that is used regularly for office and church supplies, food, etc. Renee Kristensen (Church Administrator) is the only one that is using the debit card.
  - Reviewed numbers purchases made with the Church credit card account. The card has a \$3000 limit and four staff and church members use it for technology purchases, supplies, and materials. We found documentation for these purchases to be improving through 2023. The Audit Committee recommended that all receipts are submitted to the Treasurer the month of the purchase.
- 5) Payroll records:
  - a. Payments are completed through an outside service, Intuit. Most payroll is processed electronically with some checks issued.
  - b. 6 Intuit statements were compared to bank statements to verify accuracy of debits.
  - c. Reviewed Intuit statements. Evidence that each statement was reviewed by the Treasurer was noted. Tax payments are made monthly. Quarterly the Treasurer files tax forms to the State and Federal. No irregularities were noted.
- 6) Retention of documents and financial records:

As previously established, NPC is following the guidance of accounting firm Clifton Larsen Allen and is retaining financial records for 7 years.

7) Additional recommendations:

Have an updated inventory of securities, valuables, equipment, and other non-cash assets established by Session.

Establish protocol for reviewing receipts over a threshold amount, by a Commission (probably via Stewardship).

In summary, the Committee found the financial record keeping during the year 2023 to be materially sound and accurate. We are grateful for the dedicated service of the staff and volunteers that carry out these activities of the church.
